Regulating Private Utilities (X2024.011-ZONE)

OCP & Zoning Amendment Bylaws

OCP and zoning bylaw amendments are being considered that contemplate regulating the creation of new private community water and sewer utilities.

Amendment Bylaw No. 3045, 2025, proposes to amend each of the Regional District's Electoral Area Official Community Plan Bylaws by introducing new objectives and policies discouraging the creation of private community utility systems, including those owned and operated by a strata corporation, utility or corporation.

Amendment Bylaw No. 3046, 2025, proposes to amend each of the Regional District's Zoning Bylaws by introducing new definitions for "community water system" and "community sewer system" which include systems owned and operated by the Regional District, a municipality, an Indigenous governing body or an improvement district but exclude systems owned and operated by a strata corporation, private sewer utility or business corporation.

Related amendments are also proposed to the Subdivision and Development Servicing Bylaw and Development Procedures Bylaw to regulate in favour of publicly owned and operated community systems, and to set out procedures for Development Variance Permit applications seeking to allow new private community utility systems.
