RE: Similkameen Recreation Centre Landscaping Upgrades – Construction

Services Contract Award

Administrative Recommendation:

THAT the contract for construction of the Similkameen Recreation Centre Landscaping Upgrades be awarded to Harris & Son Transport Ltd. up to the amount of \$217,767.02.

Purpose:

To proceed with the construction and landscaping upgrades at the Similkameen Recreation Centre in Keremeos. The project includes all construction services to install underground irrigation, accessible pathways and asphalt parking lot.

Business Plan Objective:

2022 Business Plan Key Success Driver 2.0: Optimize the Customer Experience, specifically Goal 2.2: To meet public needs through the continuous improvement of key services.

Background:

The Similkameen Recreation Centre was built in the late 1980's and has been operating as the primary recreational hub for the community of Keremeos and Electoral Areas "B" & "G". Recognizing the facility has aged and its growing public use, the Regional District developed a long-term plan to address upgrades and maintenance. A landscape master plan was developed in late 2021 to act as a guide for future development of the site.

Following the direction of the plan, the Regional District began moving forward with detailed design drawings for phases 1.1 and 1.2 in 2022. In 2023, the RDOS published a Request for Quotes (RFQ), based upon the Schedule of Quantities developed during the detailed design phase.

Analysis:

The Regional District received two submissions from qualified bidders during the public bidding process. However, one bid exceeded the budget, and one bid did not meet the mandatory



requirements. Subsequently, staff reviewed the scope of work and obtained a third quote in September 2023 from Harris & Son Transport.
