PLEASE NOTE:

The TAX IMPACT amount is an estimate of the difference between local government taxes and user fees that would be paid under Option 1 (Incorporation) and Option 2 (Remain Part of RDOS Electoral Area "D"), and only applies to properties with residential assessment (Class 1) that are located within the Okanagan Falls Incorporation Study Area. The resulting figure is not exact, but provides a close estimate of the impacts based on the assumptions included in the Okanagan Falls Incorporation Study analysis.

NOTES

- The spreadsheet estimates the difference between the property taxes that would be paid for the majority of the local government services under both scenarios, but does not include the entirety of your taxes. Your actual property tax bill includes several amounts that are not for local services, including hospital, school, and BC Assessment. These tax rates, and a few others that will remain the same under both options, are not included in the above calculations.
- The above estimates do not include user fees for services you receive, such as water, sewer, or garbage service. These fees are also estimated to be the same under both options, so will not change as a result of incorporation, or affect the "impact" or difference between the two options.
- The estimates are based on the comparison analysis completed as part of the Okanagan Falls Incorporation Study, and is based upon assumptions that can be reviewed in the individual Service Sheets on the website at rdosregionalconnections.ca. The comparisons assume the same service levels and tax ratios apply in both Options.
