7.1 Discussion of Roles and Responsibilities of OK Falls Parks and Recreation Commission with M. Koch (RDOS, Managing Director of Community and Environmental Services) — B. Daly (Chair) commented positively on CAO Vision Statement particularly dealing with Culture, Accountability and Service.

Discussed commission input prior to press releases.

Suggestion heard to assign a RDOS/commission liaison.

Discussed that park maintenance and project activities should be communicated to the commission on a regular basis so that the commission can address questions and concerns of community members.

Discussed providing and communicating more volunteer opportunities.

Comment heard on the vast scope of responsibilities and to possibly narrow down commission responsibilities.

Recommended the commission play a major role in bylaw revisions regarding Parks and Recreation Commissions leading to practical roles and responsibilities.
