Purpose:

To satisfy the requirements of the *Local Government Act* for the Chief Election Officer to submit a report of the assent voting results to the local government.

Reference:

Local Government Act sec. 158

Business Plan Objective:

4.0 Governance & Oversight in a Representative Democracy

Analysis:

Pursuant to Section 158 of the *Local Government Act*, the Chief Election Officer must submit a report of the assent voting results to the Local Government. The *Act* further states that in case of an assent voting by voting, the report must include a compilation of the information on the ballot accounts for the election. Schedule "A" is that ballot account for the Vote on Incorporation for Okanagan Falls.

Estimated number of eligible electors within the Okanagan Falls proposed municipality boundary: **2,031**

The Regional District uses day-of registration and does not maintain a voter's list.

Total number of valid votes cast: **1,100** Yes: 588 (53.45%) No: 512 (46.54%) Total number of eligible electors: **2,031** Yes: 588 (28.95%) No: 512 (25.21%) Total number of valid votes cast: **1,100** 54.16% of eligible electors



The breakdown for mail ballots is as follows:

Ballots Distributed	49
Ballots Returned	41
Ballots Not Returned	6
Ballots Returned Past March 22	2

A person may not cast their ballot in voting opportunities via the internet or over the telephone.

Communication Strategy:


Section 94.1 of the *Community Charter* states that notices must be placed in a newspaper that is distributed weekly, with notices placed once a week for two consecutive weeks.
