RE: Loan Authorization Bylaw No. 3106, 2025

Administrative Recommendation:

THAT Loan Authorization Bylaw No. 3106, 2025, a bylaw of the Regional District of Okanagan-Similkameen to authorize the borrowing of up to ten million dollars (\$10,000,000.00) to purchase a Corporate Building within the City of Penticton be read a first, second and third time and be forwarded to the Inspector of Municipalities for approval; and

THAT the maximum term for which debentures may be issued to secure the debt created by this bylaw is thirty years (30); and

THAT upon approval of the Inspector, approval for Loan Authorization Bylaw No. 3106, 2025 be obtained from the electorate within the Regional District of Okanagan-Similkameen through an alternative approval process (AAP) in accordance with the *Local Government Act;* and

THAT the deadline for submitting elector response forms in relation to Loan Authorization Bylaw No. 3106, 2025 to the Corporte Officer is no later than 4:30 pm on Thursday, July 31, 2025; and

THAT the elector response form attached to the report dated April 17, 2025 be the approved form for the Loan Authorization Bylaw No. 3106, 2025 alternative approval process; and

THAT the total number of eligible electors to which the alternative approval process applies is 75,283; and

THAT the number of elector responses required to prevent the bylaw from proceeding without a referendum is 7,528.

Purpose:

To provide the Regional District of Okanagan-Similkameen with the legislative authority to borrow up to ten million dollars \$10,000,000.00 to purchase a Corporate Building within the City of Penticton.

Business Plan Objective:

4.0 Governance & Oversight in a Representative Democracy

Elector Approval:

Section 345 of the *Local Government Act* and Section 86 of the *Community Charter* outline the requirements of the AAP. The Board must establish a deadline for elector response forms, establish an elector response form, and determine the number of eligible electors in the Regional District of Okanagan-Similkameen.

Staff propose statutory advertising as follows:


The deadline for elector response forms must be at least thirty days after the second publication date advertised, therefore the deadline date will be Thursday, July 31, 2025.

The Regional District of Okanagan-Similkameen does not maintain a voters list. The Regional District's GIS department has calculated that the number of eligible electors within the Regional District of Okanagan-Similkameen is 75,283. If the number of signed elector response forms received prior to the deadline is less than 10% of the estimated eligible electors, the Board may consider adopting the bylaw. If the number of signed elector response forms received prior to the deadline is more than 10% of the estimated eligible electors, the bylaw could either be abandoned or could proceed to elector assent through referendum.

Financial Implications:

Annual debt servicing costs will have an estimated tax impact of \$1.23 per \$100,000 assessed property value.

The Province of BC has developed a guide for local governments in BC on the alternative approval process. The guide, although created primarily for local government staff and elected officials, contains information which is an excellent resource for the public on helping to understand why an



AAP is held instead of an Assent Vote (referendum). Staff have developed a more condensed guide geared toward the public and a copy will be available on the AAP webpage.

Alternatives:

- 1. THAT approval for Loan Authorization Bylaw No. 3106, 2025, be obtained from the electorate within the Regional District of Okanagan-Similkameen through an Assent Voting (referendum) process.
- 2. THAT Bylaw No. 3106, 2025, not proceed.
