Introduction

2024 was a pivotal year for 100 More Homes Penticton. The addition of a dedicated Strategy Coordinator strengthened coordination, expanded sector engagement, and deepened our community impact. Membership grew by 56%, bringing new partners from diverse sectors. New initiatives like the Housing Action Table and Lived/Living Experience Table became central pillars in our collective response to homelessness.

As a collective committed to reconciliation and equity, we recognize the disproportionate impact of homelessness on Indigenous Peoples. In 2024, we took intentional steps to foster meaningful relationships with Indigenous leaders, organizations, and knowledge keepers, understanding that Indigenous engagement is not a checkbox but a guiding principle across all areas of our work.

We also advanced our strategic advocacy efforts, aligning messaging and priorities across municipal, regional, and provincial levels of government. By centering lived and living experience and grounding our work in data, we are building a strong, unified voice to influence policy, funding, and long-term housing solutions.

Our collaborative model and years of dedicated work were nationally recognized in 2024, as 100 More Homes Penticton was chosen as the only non-Reaching Home funded Community of Practice by the Ministry of Housing. This distinction supports our leadership in implementing the federal standard for housing and homelessness data.

As we move forward, we remain committed to leveraging the momentum built in 2024 to drive comprehensive, culturally appropriate, and sustainable solutions to housing insecurity, advancing our vision of a safe, stable, and inclusive community for all.

Strategic Goals

100 More Homes aims to build a coordinated system of housing & supports to address and prevent homelessness by increasing housing options, enhancing community coordination, producing reliable data for informed decision-making, and improving communication with the broader community. Through collaborative efforts we focus on reducing inflow into homelessness, increasing outflow through stable housing placements, and minimizing recurrence by addressing gaps in the existing support system.

01. Housing & Supports



Increase housing and supports for those experiencing and at risk of homelessness.

02. Quality Data



Produce consistent, reliable data to inform decision-making and advocacy.



03. Community Coordination



Create a coordinated system of intake, assessment and supports.

04. Communication



Enhance communication and education to the wider community.



Measuring Progress

Through collaboration & innovation, we made significant strides in addressing homelessness by centering lived/living experience, enhancing community engagement, & building strong partnerships. Key achievements include launching the Lived/Living Experience Table and Housing Action Table, increasing public engagement, & earning regional and provincial recognition for leadership in coordinated housing solutions.



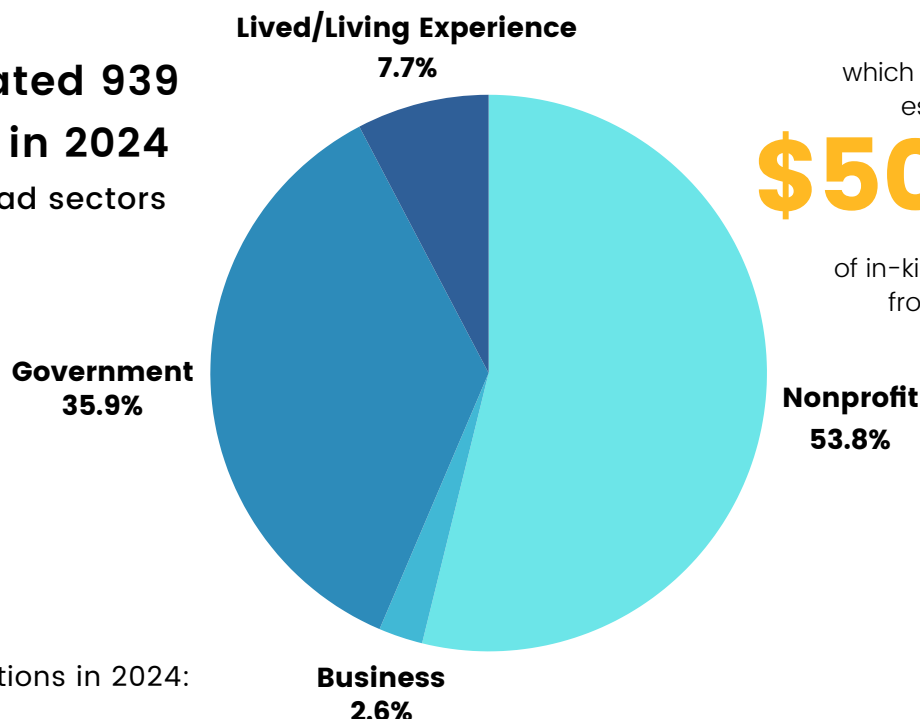

2024 Partner Contributions

The impact of 100 More Homes is made possible through the unwavering dedication of our partners, who contribute time, resources, and expertise to address homelessness in our community. From government agencies to nonprofit organizations, local businesses, and individuals with lived experience, each partner plays a critical role in building collaborative, sustainable solutions.

Partners dedicated 939 hours to 100MH in 2024

Key Partner Contributions in 2024:

- Delivered over 500 collective volunteer hours to support litter removal, public space maintenance, and community engagement through the Community Clean-Up initiative
- Engaged over 40 nonprofit, business, and government partners in collaborative efforts to develop the Social Housing and Infrastructure Plan (SHIP)
- Facilitated cross-sector collaboration to address public safety and homelessness challenges, reducing bylaw calls by 66% and fire department responses by 95% through coordinated efforts
- Enhanced media engagement and public awareness through storytelling, advocacy, and data-driven messaging, fostering a more informed and supportive community environment

Next Steps

As 100 More Homes Penticton moves forward, the focus is shifting from crisis response to long-term, preventative strategies that address the root causes of homelessness. With strong foundations in place—from emergency shelter coordination to the launch of the Housing Action Table—the collective is committed to advancing community-led solutions like the Social Housing & Infrastructure Plan (SHIP) and prioritizing the development of a Youth Housing Initiative. Continued efforts will deepen collaboration, strengthen data systems, and ensure lived experience remains central to building a more stable, inclusive housing system.



01. Youth Housing

The 2022 Nowhere To Go Report outlined critical gaps in youth housing services in Penticton, and 100MH will work to address these by continuing work on developing a community-driven Youth Housing Initiative. This is driven by the knowledge that by addressing youth homelessness, we are preventing adult chronic homelessness and promoting shelter diversion.



02. From Crisis to Stability

Building on the success of the emergency weather response model developed over the past few years, we are now shifting our focus from reactive crisis-response to proactive, long-term strategies. This evolution reflects growing capacity within the collective to respond to emergency needs while simultaneously building the foundation to prevent homelessness before it begins.



03. Social Housing & Infrastructure Plan

100 More Homes continues to lead community-driven efforts to advance the SHIP. Through inclusive coordination of government, non-profits, developers & lived experience, the initiative supports shared planning for affordable housing solutions. The Housing Action Table plays a key role in driving the SHIP forward by aligning local priorities with broader housing strategies.

Conclusion

The achievements outlined in this report reflect the dedication of our partners and the strength of collaboration in addressing homelessness in Penticton. As we move forward, we remain committed to leveraging these successes to build a resilient, inclusive community where homelessness is brief, rare, and non-recurring.
