4. RDOS STAFF REPORTS — J. Shuttleworth (RDOS, Manager of Parks)

4.1 2025 Budget First Reading Review — Report heard on the *Commission Annual Timeline*. Each year in January, a list of the following years' projects to be submitted to staff by the commission.

The 2025 Budget has been approved. Reported on increased costs associated with services and service areas.

4.2 Future Capital Projects — Presentation given on *Electoral Area 'E' - (2024-2029) - Summary of Proposed Projects*.

Discussed active projects, 2026 projects, funding, strategic planning, and budget.

The Dog Park will be put back on the summary. Discussions with the Naramata Centre are ongoing.

Question heard regarding the Spirit Park budget. Discussed budget carryover and budget remaining.

A funding opportunity is being looked into through the School District 67's Arrive Safe initiative.

RDOS staff can be contacted if higher service levels are needed.

The commission requested information on if electricity was installed in the Spirit Park bandshell, if an adult height basketball hoop can be installed in the sports court, and how the circuit works on tennis and sports court lighting.

5.1 Parks Maintenance Contractor — A. Fedrigo (Director, Electoral Area "E") reported that the RFP for the contract received three (3) bids from new proponents which were all well over budget. The previous contractor did not apply. RDOS board moved that the contract become an employed position.
