Administrative Recommendation:

THAT the Board of the Regional District of Okanagan-Similkameen authorize up to \$921,324.24 be borrowed, under Section 403 of the *Local Government Act*, from the Municipal Finance Authority, for the purpose of purchasing curbside collection carts; and

THAT the loan will be repaid within five years, with no rights of renewal.

Purpose:

To ensure there is appropriate funding for the curbside cart program.

Reference:

Local Government Act section 403 Community Charter section 175

Strategic Priorities:

Strategic Priorities 24.172 Curbside cart purchase and delivery

Background and Analysis:

The total cost for purchase and deployment of the curbside cart program less GST is \$2,306,304.95. The director of each Electoral Area participating in the curbside service was provided funding options and the chart below represents the decisions that each director made. Directors for Electoral Areas "D", "F", and the Village of Keremeos have elected to fund a portion of the curbside carts through the MFA Equipment Financing program. In addition, the Electoral Area "E" director has elected to fund all the curbside carts through the Equipment Financing program. As such, curbside clients in these areas will have an annual debt servicing charge over five years to cover their portion of the \$921,324.24 loan.
